Mission

Australian Catholic University shares with universities world wide a commitment to quality in teaching, research, and service. It aspires to be a community characterised by free inquiry and academic integrity.

The University's inspiration, located within 2,000 years of Catholic intellectual tradition, summons it to attend to all that is of concern to human beings. It brings a distinctive spiritual perspective to the common tasks of higher education.

Through fostering and advancing knowledge in education, health, commerce, the humanities, the sciences and technologies, and the creative arts, Australian Catholic University seeks to make a specific contribution to its local, national and international communities.

The University explicitly engages the social, ethical and religious dimensions of the questions it faces in teaching, research and service. In its endeavours, it is guided by a fundamental concern for justice and equity, and for the dignity of all human beings.

Australian Catholic University has a primary responsibility to provide excellent higher education for its entire diversified and dispersed student body. Its ideal graduates will be highly competent in their chosen fields, ethical in their behaviour, with a developed critical habit of mind, an appreciation of the sacred in life and a commitment to serving the common good.

History

Australian Catholic University (ACU National) was established in November 1990 through incorporation as a public company limited by guarantee, registered in the State of Victoria. It was subsequently recognised as a University under the Australian Catholic University (Victoria) Act 1991 and provides this report to the Minister for Skills, Education Services and Employment.

The University was formed through the amalgamation of the Catholic College of Education (NSW), the Institute of Catholic Education (Vic), McAuley College (Qld) and Signadou College of Education (ACT).

Today, ACU National has six campuses nationally: Brisbane (McAuley at Banyo), North Sydney (MacKillop), Strathfield (Mount Saint Mary), Canberra (Signadou), Ballarat (Aquinas), Melbourne (St Patrick's).

Chancellor's foreword



It would be impossible to begin this foreword without firstly acknowledging the inspirational vision and compelling leadership of Vice-Chancellor Professor Peter Sheehan AO, whose decade at the helm of an ever stronger ACU National has come to a close.

Professor Sheehan's charismatic leadership continued to encompass support for the student body with the launch in 2007 of ACU National Wired radio, along with a strengthening of graduate relations.

A Catholic university by definition does not exist in isolation. It is part of the Church and wider human communities and a member of a worldwide network of Catholic tertiary education providers. As such, it has obligations to the communities from which it draws its students and to the communities in which its graduates find employment, and to all people as it lives out its Mission.

As our Mission states, the ideal graduates of ACU National are 'highly competent in their chosen fields, ethical in their behaviour, with a developed critical habit of mind, an appreciation of the sacred in life, and a commitment to serving the common good'.

At our Catholic University, community engagement is a highly valued vehicle for expressing and achieving our Mission, through partnerships in which equality is respected and shared goals articulated.

Our students and staff approach engagement with the expectation that they will have something to learn from the community groups and individuals with whom they collaborate on a particular project or activity, together achieving a more just society.

As in the past, throughout 2007, educational opportunities have been provided to refugees on the Thai-Burmese border in collaboration with the Jesuits. Engagement with the Catholic teachers' college in East Timor in collaboration with the Marist Brothers continued, along with other valuable programs. These activities have been applauded jointly by the Congregation for Justice and Peace and the Congregation for Catholic Education in Rome.

Closer to home, the Clemente Australia program, providing tertiary education opportunities for people who are marginalised in collaboration with Mission Australia and the St Vincent de Paul Society and others, has continued to grow during 2007, spreading to Brisbane, Canberra and Melbourne, attracting the imagination and support of businesses, and earning a string of prestigious awards.

These advances in the life of the University have lifted up minds and hearts and raised the morale of staff, students and partners immeasurably. We celebrate our unique strengths.

The partnerships, professionalism, academic achievement, and staff loyalty Professor Sheehan has fostered in 2007 and the preceding years leave ACU National in exceptionally good health, enjoying well-deserved respect in the world of tertiary education and beyond.

The activities and reach of ACU National, as a public institution in a resources-rich nation, are indeed of critical importance, for our Catholic heritage recognises that education is the right of all people, and liberation for many deprived people will come only through education. The expertise we share and foster, for the common good, is vital.

In farewelling Professor Sheehan, we now address the future of our public, Catholic university. In 2007, from a strong field of extremely high quality candidates, Professor Greg Craven was selected as new Vice-Chancellor, to take up his position in early 2008.

Professor Craven has enjoyed a distinguished career in academia, the law and public life. In addition to his two years as Deputy Vice-Chancellor at Curtin University of Technology, Professor Craven was the foundation Dean and Professor of Law at the University of Notre Dame Australia. Prior to this he held academic positions at the University of Melbourne, and has also served as Crown Counsel for the State of Victoria.

Importantly, Professor Craven identifies strongly with the academic, social and spiritual ethos of ACU National. He is ideally placed to take this important University into an exciting future and we welcome him.

In closing, may I extend my personal thanks to Professor Sheehan and indeed to all our staff, students, graduates and partners, for their mutual contributions to ACU National during 2007 and for all that our University has achieved.

Vice-Chancellor's statement



In this, my 2007 and final Annual Report, I will begin by putting on record my immense pride in the achievements of our graduates, our students and the staff of Australian Catholic University (ACU National). Now, as in the past decade, I can express only admiration for their tremendous commitment to our unique University and to its vital Mission.

Most organisations survive on the common sense of the people who are working in them. ACU National survives and thrives through the extraordinary commitment and dedication of the people who work for and with this University which dares to be different.

The University has experienced enormous growth in the past 10 years. Student numbers have grown by 36 per cent, from 10,577 students in 1988 to 14,362 students in 2007.

Our research revenues have tripled in that same time. Our Professoriate has doubled from 16 to 32, and our infrastructure has increased significantly to support the growth.

However, for institutions to be healthy and to thrive, growth alone is insufficient. What matters to me is what that growth achieves, and I am proud to report that I believe we have achieved a wonderful level of quality as a unique Australian university.

Quality has been in evidence throughout the decade and no less so during 2007, when academic staff have achieved public recognition for their quality at unprecedented levels.

In 2007, a record 13 members of staff from across all our faculties were awarded citations from the Carrick Institute for Learning and Teaching in Higher Education for outstanding contributions to student learning.

These and many other members of staff, at every campus, have led by example, engaging with students, Australian and international colleagues and communities, sharing their views and expertise, incrementally adding to the depth and breadth of our University's influence and standing. Their commitment, experience and generous work continue to build credibility and respect for the quality and distinctiveness of ACU National and for all that it does and achieves.

In 2007, the quality of the tertiary education we provide once again received high praise in *The Good Universities Guide 2008*. This time, graduates recognised in particular 'positive graduate outcomes', 'entry flexibility', 'getting a job', 'Indigenous participation' and 'staff qualifications'.

financial summary

Revenue

Total government grants increased by \$8.5 million (8.62 per cent) over 2006, in particular the Commonwealth Grants Scheme of \$6.04 million.

Other operating revenue increased by \$10.52 million (22.33 per cent), including an increase in fees and charges of \$4.34 million and other revenue of \$5.14 million. Total revenue increased by \$18.59 million (12.83 per cent).

Expenditure

Salary expenditure excluding provisions increased by \$11.98 million (14.57 per cent) and non-salary cash expenses increased by \$6.28 million (17.84 per cent). Total expenditure, including non-cash transactions for depreciation, amortisation and transfers to leave provisions increased by \$18.49 million (14.61 per cent).

Operating result

There was a positive operating result of \$18.36 million, an increase of \$0.96 million (0.53 per cent) over the result for 2006 of \$18.27 million. The positive result is attributed to operating activities of \$10.17 million and capital activities of \$8.2 million.

Working capital

There was an improvement in the working capital position from a surplus of \$17.07 million in 2006 to a surplus of \$34.79 million in 2007 due principally to an increase in cash and investments.

Borrowings

There was a reduction in total borrowings from \$0.8 million in 2006 to nil in 2007.

Net assets and reserves

Net assets and reserves increased by \$18.45 million. The increase in reserves comprised \$18.36 million from net operating profit and a revaluation increment to the available for sale financial revaluation reserve of \$0.09 million.

Infrastructure developments

To cope with the growth in student numbers, additional teaching and administrative space was leased during 2007 in close proximity to both the Melbourne and North Sydney campuses.

Refurbishment of the leased areas with associated works on the main campuses was also carried out.

A long-term capital planning review undertaken in late 2006 identified the need for further significant capital infrastructure expenditure in Melbourne, Sydney and Brisbane and this will be undertaken during 2008 and 2009. The expansion will be funded from University cash reserves, augmented with external loan borrowings.

Teaching and learning is the core business of ACU National, and a commitment to quality in these areas is integral to the University's Mission and Strategic Plan.

In keeping with a culture of review introduced by Vice-Chancellor Professor Sheehan AO with the development of the University's Strategic Plan almost a decade ago, the University continued to welcome student evaluation of teaching and learning, and to review and improve course delivery, assessment, the learning environment and outcomes throughout 2007.

With the study of ethics, theology and philosophy integrated into curriculum areas at ACU National, staff and students are encouraged to interpret and reflect on their values in original, personal and authentic ways. Expertise is nurtured within a context of community responsibility.

The special strengths of teaching and learning at our University, enriched by research, achieved recognition from a number of sources in 2007. Among them, staff and students were selected for a number of external awards, the University received funding for international educational initiatives, and, in response to community needs, we strengthened our relationships with collaborators.

Quality teaching and learning

During 2007, ACU National continued to strengthen its reputation as a provider of quality teaching and learning with the implementation of many new initiatives. Some were funded through the Learning and Teaching Performance Fund allocation by the Commonwealth Government, the purpose of which is to reward universities for demonstrated excellence in teaching and learning.

There were key developments in the area of online education, with the endorsement of the Strategic Plan for Online Teaching and Learning 2007–2009. The plan establishes specific goals for online teaching and learning and identifies ways of putting into practice relevant policies for a number of projects already in train, and to identify new objectives, projects and strategies. The foundation Director of Flexible Teaching and Learning was appointed to provide University-wide leadership for online teaching and learning, including oversight of implementation of the plan and responsibility for pedagogical leadership

and coordination and alignment of the pedagogical and technical dimensions of online teaching and learning. A project funded by the Carrick Institute for Learning and Teaching in Higher Education allowed the further development of staff skills in online course development and delivery with the appointment of six online advisers.

The First Year Experience (FYE) program was introduced across all campuses of the University in 2007 to support the transition of students to university. The program is coordinated by the University FYE Coordinator, in turn supported by six campus-based FYE Coordinators. Feedback from students, via the new FYE Committee chaired by the Pro-Vice-Chancellor (Quality and Engagement), has indicated that the program has been welcomed by students and was successful in its inaugural year.

During 2007, ACU National continued its success with respect to applications for Carrick Institute for Learning and Teaching in Higher Education projects and awards. These included nine citations for

Outstanding Contributions to Student Learning and a discipline-based collaborative theology grant for a scoping project to establish the depth, reach and utility of Australian theological education.

Academic Board and standing committees

In 2007, Academic Board undertook a review of its terms of reference and membership, resulting in a reduction in the professorial representation on the committee. The terms of reference and membership of the board's standing committees were also reviewed with recommended changes approved by Academic Board. With the completion of the review of the faculties' discipline profile, the decision was made to establish two new institutes, one in Business and Informatics, and the other in Theology, Philosophy and Religious Education.

A new national School of Theology brought together the four Schools of Theology for the first time in 2007.

The Asia-Pacific Centre for Inter-religious Dialogue commenced its first full year of operation promoting dialogue, mutual understanding, respect and collaboration between Christians and other religious communities through the provision of related research and scholarship, teaching and learning, and community engagement. As detailed later in this report, the Centre's inaugural Chair was appointed.

In 2007, Academic Board approved the new Strategic Plan for Online Teaching and Learning 2007–2009 and a number of new and revised policies and related documents, including:

- guidelines for the coding and naming of units
- policy and procedures on educational partnerships, including guidelines on educational partnerships, affiliations and other collaborative arrangements
- revised 2009 Teaching Development Grant Program Guidelines
- revised graduate attributes
- revised policy on recognition of prior learning and guidelines for implementation of the policy on recognition of prior learning; and
- revised procedures for 2008 ACU National Excellence in Teaching Awards.

Academic Board and the University Senate approved the following new courses to commence in 2008:

- Bachelor of Nursing/Bachelor of Paramedicine
- Graduate Certificate in Clinical Education
- Graduate Certificate in Leadership and Catholic Culture
- Non-award Diploma in Exercise Science

 A suite of nested courses in Early Childhood Education.

- Master of Arts (Liturgy), including the exit qualification of Graduate Diploma in Arts (Liturgy)
- Master of Social Work
- Postgraduate Certificate in Child Protection and Communities
- Social and Emotional Learning, Evaluation and Sustainable Futures in the Postgraduate Certificate in Education and Master of Education.



The following existing courses were approved for offering off-shore:

- Bachelor of Nursing in Hong Kong
- Certificate and Diploma in Educational Studies in Singapore.

The following changes to course titles were approved:

Goals Committee

The Goals Committee met regularly and instigated and supported a wide range of activities to promote the unique Mission of the University. Several successful forums, lectures, conferences and other activities were held, including the following:

- in collaboration with several other Catholic agencies, a colloquium on Mission and Identity hosted by the University at the Melbourne Campus in April. It was the first such gathering and offered the 105 participants a unique opportunity to discuss and scrutinise the nature of Catholic organisations' identity
- public lectures in Brisbane, Strathfield and Melbourne on the topics of A Catholic university and prophecy, A Catholic university and lay stewardship and A Catholic university's compelling deep story, as well as a conversazione at the Melbourne campus on Culture and prophetic critique in Catholic-sponsored institutions with Professor Bernard Lee SM in July
- a conversazione on contemporary issues relevant to Catholic education with Archbishop Michael Miller CSB in North Sydney in August
- forums for students and staff on the Church's social teaching held at the Melbourne and Strathfield campuses in August and September
- presentations by Mr Duncan McLaren, outgoing General Secretary of Caritas Internationalis and Visiting Professor at the University from August to December, who was based in North Sydney but visited other campuses and delivered public lectures
- a joint forum with Caritas Australia to mark the 40th anniversary of Pope Paul VI's Populorum Progressio held in November and focusing on developing a set of principles for an integrated approach to the Church's contribution to aid and development in the Pacific and East Timor.

Embracing change

Evaluation and reviews continue to inform and improve quality teaching and learning at ACU National.

In 2007, the systematic use of both unit evaluation and Course Experience Questionnaire (CEQ) data, incorporated within the University's Teaching and Learning Plan, informed curriculum reviews at course and unit levels, while evaluation processes have been complemented by the biennial Quality and Administrative Support Services (QASS) survey of returning students' assessment of services, and the Course Completion Surveys (CCS) of graduating

Teaching and learning was supported by an ongoing commitment to suitable library services, with the acquisitions budget reaching \$2,188,589 in 2007. In keeping with policy, a growing proportion of these funds is being spent on electronic resources. The increase in funding was accompanied by the establishment, on each campus library, of liaison librarians who work with specific schools to ensure the collections and services are aligned to the needs of the entire University community.

Five-star ratings

In 2007, ACU National once again achieved a number of coveted 'five-star' performance ratings in the 2008 edition of *The Good Universities Guide*, published by Hobsons.

ACU National's NSW and ACT campuses – North Sydney, Strathfield and Canberra – received five stars for Entry Flexibility, Graduate Employment, Positive Graduate Outcomes and Staff Qualifications.

The Melbourne Campus and Ballarat Campus in Victoria achieved five stars for Entry Flexibility, Graduate Employment, Student-Staff Ratio and Positive Graduate Outcomes.

The Brisbane Campus was given five stars for Graduate Employment, Indigenous Participation, Positive Graduate Outcomes and Staff Qualifications.

International immersion

An award-winning, pioneering model of experiential learning for nursing students in partnership with health care providers in Vanuatu paved the way for a newly introduced Faculty of Health Sciences policy on international community immersion.

ACU National formally launched its Institute of Legal Studies (ILS) with a lecture by international human rights expert Professor Cathleen Kaveny, the John P Murphy Foundation Professor of Law and Professor of Theology at Notre Dame Law School in Indiana, USA, who spoke on *Hope, Solidarity and Human Rights*.

A Social Justice Youth Forum, attended by approximately 300 senior students from Catholic schools, was held at the Brisbane Campus in June.

Indigenous education

Building on our record of success in providing Indigenous education, the University approved the establishment of a Centre for Indigenous Education, bringing together its three Indigenous education units with a national focus. The Centre is to pursue the objectives of a newly agreed strategy for Indigenous Education and Research, giving expression to national priorities within the context of the University's distinctive Mission.

The Carrick Award for Teaching Excellence in Indigenous Education was won by Weemala Indigenous Education Unit Coordinator Dr Nereda White, from the Brisbane Campus, who also received the only 2007 Neville Bonner Award for Indigenous Education.

The National Indigenous Education Consultative Committee award for Indigenous elders was presented to Aunty Joan Hendricks, an elder of the Nguigi people who assists Weemala in its work.

A \$20,000 postgraduate scholarship for current and new research candidates of Aboriginal and Torres Strait Islander descent was announced, kindly donated by the Pratt Foundation. It is for full-time research in any field of scholarly research within the faculties of Arts and Sciences, Education, or Health Sciences leading to a Master's or Doctoral degree. A number of staff, students and friends of ACU National celebrated Indigenous Week at the University. At the Ballarat Campus, the Wautharong people were acknowledged as the traditional Indigenous owners and custodians of the land, and message sticks were discussed at weekly Mass, where a symbolic stick was blessed and installed in the Chapel. At the Strathfield Campus there was a flagraising ceremony, and third-year education student Jennifer Hodges and first-year education student Matthew Shiels spoke on the theme *Looking forward, looking back*, reflecting on the development of the campus's Yalbalinga Indigenous Support Unit.

The Flagship of Creative and Authentic Leadership, in partnership with the Batchelor Institute of Indigenous Tertiary Education (BIITE), continued to make progress in the *Linking Worlds* project, funded by the Australian Research Council. The project targets higher education institutes already engaged in significant work with Indigenous students. The purpose of *Linking Worlds* is to investigate cultural influence on educational leadership in remote Aboriginal communities, and to appreciate how an understanding of this might assist in strengthening the capacity of educational leaders to develop culturally appropriate Indigenous teaching and learning programs. This partnership also received funding from the Carrick Institute for an Excellence in Learning and Teaching Program.

The School of Education (Queensland) worked on Community-based mentoring: An exploration of a model for supporting and retaining teachers in rural and remote communities in Queensland, with activities currently centred on Springsure and Moonie.

Reviews of the Indigenous education programs in the Faculty of Education led to new programs being developed and approved. The Bachelor of Education (Primary) (Indigenous Education) was successfully revised, while the Diploma in Aboriginal and Torres Strait Islander Education was revised and renamed as Associate Degree in Indigenous Education.

The Faculty of Arts and Sciences and the Faculty of Education worked together to establish a dual degree Bachelor of Teaching/Bachelor of Arts in a mixed mode which will allow the Indigenous pre-service secondary teachers to work mainly in their own communities while studying and completing their dual degree.



Supporting education in the region

ACU National was awarded \$423,500 by the Commonwealth Government to help support educational leadership development in Asia through the *Mastering the new basics in education leadership* program. Carried out by ACU National's Flagship for Creative and Authentic Leadership and funded via AusAID's Australian Leadership Awards fellowship program, it included a three-day seminar in Ho Chi Minh City for Australian Leadership Awards (ALA) Fellows from Cambodia, Laos, Vietnam and East Timor.

In an agreement with Anglicare, the Australian Leadership Consortium, involving ACU National's Flagship for Creative and Authentic Leadership and the Australian Centre for Educational Leadership at the University, developed and implemented a leadership development program for senior Anglicare executives.


Representatives of diocesan Catholic education offices, religious congregations and the School of Educational Leadership worked together to develop

a framework for leadership in Catholic education. Engagement with the Catholic education community also included the *Leaders Transforming Learners* and *Learning* (LTLL) project and the hosting of an international leadership conference in Sydney with the theme *Directions for Catholic Educational Leadership* in the 21st Century.

International student enrolments continued to increase in 2007. Although the largest enrolments were in nursing, other fields, such as business, showed healthy growth. The largest numbers of students were from India, China, Korea and Nepal.

A new full-time study abroad and student exchange advisor position was created in 2007. Part of this role involves the development of opportunities for Australian students to spend a period of their study at one of the universities with which ACU National has an exchange agreement. A program to provide financial support for students on outgoing exchange has also been implemented.

ACUcom

ACUcom provides Group Study Abroad programs for groups of students coming from overseas universities. For example, 90 Italian students from Universita Cattolica del Sacro Coure were involved in a variety of internship programs in Melbourne, many in the not-for-profit sector, offering benefits to both the employers and interns. Other Italian students have been involved in English language and Australian culture programs. In other initiatives Group Study Abroad programs included students coming to ACU National from Germany, France, USA, Japan and Korea to take part in programs tailored to meet the specific needs of the home university.

During 2007, ACUcom also provided specific programs in Education, such as TESOL, programs for teachers of languages other than English (LOTE), and Inclusive Schooling.

The international sector of ACUcom provides English Language and Diploma Pathway programs for entry into the University. English Language Intensive Courses for Overseas Students (ELICOS) continued to be in heavy demand.

ACU National is committed to conducting research which is relevant, responsive to community need and supportive of our Mission. We seek to undertake research which assists communities, government and non-government agencies and industries to effectively and creatively improve services, health care and education, and to make the world a better and more humane place in which to live.

In 2007, our research activities focused primarily on health, education, sport and exercise science, environmental science, community welfare, psychology, social science and the humanities. In keeping with our Catholic character and history, the University has world-class research strengths in early Christian studies, theology and philosophy.

While much of our research was conducted in designated flagships, centres and institutes, outstanding contributions were also made by academics across all our campuses. Importantly, their specialised research informed our teaching and learning activities; and their expertise inspired our students and attracted industry and media attention.

A great strength of ACU National is its capability to conduct research and link with partners across multiple geographic areas nationally and internationally. Much of our research is funded by external organisations, industry and all levels of government. Many academics conducted joint research with colleagues from other universities in 2007, enabling us to form valuable collaborations and strengthen our impact.

Informing education

A Best Paper Award for *The challenge of attracting and keeping quality teachers in Australian schools* was awarded to the Head of the School of Arts and Sciences (NSW and ACT) Dr Tony Stokes and economics lecturer Ms Sarah Wright at the 2007 International Business and Economics Research conference and Teaching and Learning conference in Las Vegas.

ACU National Centre for Lifelong Learning Director Professor Judith Chapman and her colleagues edited three new books in the International Series on Lifelong Learning.

The Department of Education, Science and Training awarded ACU National funding for an Indigenous education project *Enabling home school transition:* Using Indigenous students' oral language as the foundation for literacy and numeracy learning and teaching.

Faculty of Education Research Associate Dean (Research Training and Partnerships) Associate Professor Elizabeth Warren and Mathematics Literacy Education Research Flagship Senior Lecturer Dr Janelle Young received \$87,460 over 20 months to extend their research into literacy and numeracy. Their research involves the Flagship, Cairns Diocese and Independent Schools Queensland and the new funding has allowed a Catholic primary school on Thursday Island and a public school at Yarrabah to become involved in the study.

Research from the Faculty of Education included seeking perceptions from employers about credentials that are appropriate for Australia's workforce for the 21st century. A Mathematics and Literacy Education Flagship funded project focused on using Computer Algebra Systems (CAS) to enhance the teaching of mathematical modelling. As part of the project, the Flagship worked with seven schools in both Brisbane and Canberra.

The School of Education (ACT) took part in the network of state and territory hub organisations of the National Centre for Science, Information and Communication Technology, and Mathematics Education in Rural and Regional Australia (SiMER). Funded by the Department of Transport and Regional Services, the network has continued throughout 2007 to conduct many research and professional development activities for primary, secondary and tertiary educators.

School of Education (Vic) Associate Professor Joseph Zajda was awarded a Queensland Department of Education, Training and Arts and Eidos Science and Training grant of \$82,500 to conduct a research project on *The importance of qualifications – credentialism in the 21st century*. Team members included Associate Professor Zajda and Professor Philip Clarkson of the School of Education (Vic), and Faculty of Education Research, Research Training and Partnerships Associate Dean Associate Professor Elizabeth Warren, along with Queensland University of Technology Professor Carmel Diezman.

Associate Professor Zajda was also invited by the UNESCO Institute of Education to join the board of consulting editors for their internationally acclaimed refereed journal *International Review of Education*, the oldest scholarly journal in the areas of international education and comparative education research in the world, circulating in some 200 countries.

Improving health and well-being

Initiatives and activities of the University's Centre of Physical Activity Across the Lifespan (CoPAAL) resulted in an increased number of research grants, publications, research students and projects undertaken with sporting and health care industry partners.

The National Centre for Clinical Outcomes Research (NaCCOR) was established to focus on the research and scholarly activities within the Faculty of Health Sciences to improve health care, and to contribute to public debate and influence policy. The Centre was designed to be a 'virtual network' embedded in the three Schools of Nursing and Midwifery.

Centre Director Professor Sandy Middleton and UNSW colleagues were granted \$476,350 by the National Health and Medical Research Council to conduct a Randomised controlled trial to evaluate a model of comprehensive stroke care.

In partnership with St Vincent's Health Melbourne, the University announced the appointment of Dr Linda Worrall-Carter, pictured on page 28, to the newly created role of Chair in Nursing Research. Dr Worrall-Carter's time will be shared between the School of Nursing and Midwifery (Victoria) at ACU National's Melbourne Campus and St Vincent's Hospital, where she has established a Clinical Nursing Research Unit.

A study by School of Psychology Associate Professor and Reader Dr Peter Rendell showed dangerous effects of ecstasy use on memory. In the study, published in the journal *Psychopharmacology* in late 2007, Dr Rendell and colleagues including Dr Julie Henry of UNSW found that even infrequent ecstasy use has a significant negative impact on a part of memory function called prospective memory.

The Centre of Physical Activity Across the Lifespan (COPAAL) received an ARC Linkage Grant for Tracking the musculoskeletal health and performance of talented adolescent female athletes. Other major research included The relationship between musculoskeletal screening and injuries in athletes at the NSW Institute of Sport, in partnership with the Institute and University of Ballarat. Other research

included Why families choose not to participate in child obesity research, with Murdoch Research Institute, and Profiling physiological and psychological health of apprentice jockeys.

Enhancing human services

A report providing a unique perspective on children's experiences of homelessness, *Finding their way home:* Children's Experiences of Homelessness, was prepared by an Institute of Child Protection Studies research team. It was commissioned by the ACT Department of Disability, Housing and Community Services with funding through the Australian Government's Supported Accommodation and Assistance (SAAP)

The Supporting children and families affected by alcohol or other drug use study is being carried out by the Institute of Child Protection Studies and Anglicare's young carers support organisation CYCLOPS ACT. The study will provide young people with the opportunity to have their say about what their parents' drug or alcohol use means to them, what roles they assume in their families and what kind of support they need.

"Our study aims to not only better understand children's experiences but also uncover how to provide support services that actually make a difference in these children's lives. As such, we will work closely with a range of support organisations on this project – including the drug and alcohol sector and services for families and youth – to identify the best ways of assisting children and families living under these circumstances."



ACU National and Anglicare Canberra and Goulburn announced a new study funded by the Australian Capital Territory Government, to give a voice to children living with a drug or alcohol dependent parent.

A joint research report, Recovering from the 2003
Canberra bushfire: A work in progress, found that
many people affected by the 2003 bushfires believe
their local communities and neighbourhoods were
strengthened after the fires and that the Bushfire
Recovery Centre at Lyons became a lifeline to those
who had lost their homes or had suffered other losses.
It was conducted by researchers at ACU National,
the University of Canberra and the ACT Department
of Health, and funded by Emergency Management
Australia, under their Research and Innovation
Program, with support from the ACT Government.

Research into workplace counselling dispelled the myth that Aussie men are reluctant to seek professional support in dealing with personal issues. The research was conducted by Dr Robert Compton in the School of Business and Informatics (NSW) in partnership with consulting firm Davidson Trahaire Corpsych.

Professor Shurlee Swain of the School of Arts and Sciences was elected a Fellow of the Academy of Social Sciences and obtained an Australian Research Council (ARC) Discovery Grant to research the early history of the Family Court of Australia, with University of Melbourne academic Ms Helen Rhoades. A total of \$350,000 has been awarded over three years.

In October 2007, the Faculty of Arts and Sciences Research Centre for Social, Emotional, Cognitive and Behavioural Development hosted a well-attended conference *Dealing with diversity in a complex, global* world at the University's Melbourne Campus.

Understanding and managing eating disorders in the school setting, a paper by postgraduate psychology student Bridie Hellings and Senior Lecturer in Psychology Dr Terry Bowles was published in the Australian Journal of Guidance & Counselling, volume 17, number 1, 2007.

Ethics and other expertise

ACU National and the Forum of Australian Catholic Institutes of Theology (FACIT) Taskforce announced results of a nine-year study, led by ACU National, into enrolment trends in undergraduate and postgraduate theology courses. Overall results pointed to a surge in postgraduate enrolments over the past decade.

FACIT member institutions include ACU National, Broken Bay Institute, Catholic Institute of Sydney, Catholic Theological College Melbourne, Catholic Theological College of South Australia, Jesuit Theological College, John Paul II Institute of Marriage and the Family, St Paul's Theological College, University of Notre Dame Australia and Yarra Theological Union.

ACU National formally launched its Institute of Legal Studies (ILS) with a rare Melbourne lecture by international human rights expert Professor Cathleen Kaveny, the John P Murphy Foundation Professor of Law and Professor of Theology at Notre Dame Law School in Indiana, USA, who spoke on *Hope, Solidarity and Human Rights*.

The 10th anniversary of the founding of the University's Centre for Early Christian Studies was celebrated with a state reception in Sydney. A major ARC grant was received in 2007 for researching *Poverty and welfare in late antiquity*. The centre is liaising with Japanese colleagues researching a similar project.



Much media attention was generated by *The Spirit* of *Generation Y: Young people's spirituality in a changing Australia*, a book by Quality of Life and Social Justice Flagship Director Associate Professor Ruth Webber, Research Fellow Rev Dr Michael Mason and Monash University's Dr Andrew Singleton, and published by John Garratt Publishing.

ACU National and St Vincent's and Mater Health in Sydney renewed their support for the Plunkett Centre for Ethics, pledging to contribute more than \$1.3 million over the next five years. The Plunkett Centre explores moral and ethical dimensions of the health care profession.

Environmental scientist Dr Vaughan Monamy received a grant of \$185,552 from the NSW Environmental Trust to research *Mosquito control, saltmarsh and insectivorous bats: seeking a balance*; and funding from the NSW Roads and Transport Authority for a project entitled *Ameliorating vehicle-marsupial collisions: a role for chemical repellents*.

Dr Catriona Mackenzie from Macquarie University was selected as the winner of the \$10,000 2007 Australian Catholic University Eureka Prize for Research in Ethics. Her work, *Relational autonomy and moral imagination*, explores the concept of individualism and its effect on the well-being of society as a whole.

It is through engaging with communities that ACU National, with the help of valued partners, shares and builds its expertise and resources to empower and enhance capacity in diverse communities.

The University's Mission-focused commitment to community engagement was demonstrated in 2007 not just through the establishment of the Institute for Advancing Community Engagement, but in a myriad of ways.

In the quest for social justice and human dignity, through the informed and caring engagement of staff, students, graduates and partners alike, a host of individuals and communities experienced change for the better.

The University's communication and marketing activities form an essential component of our engagement with partners and stakeholders, prospective and current students, staff and the broader community. A core strategy has been our evidence-based approach, sharing the real-life stories of successful students, graduates, staff and programs.

Integral to the strategic plan

Through community engagement the University truly lives its Mission, promoting the dignity of people and advancing the common good.

The University's community engagement both is enhanced by and enhances the University's teaching and learning and research and is acknowledged widely as an important source of optimism for people, communities and institutions.

Key structures

In 2007, the University endorsed the importance of community engagement through implementing key structures including the role of Pro-Vice-Chancellor (Quality and Engagement) and the newly established Institute for Advancing Community Engagement.

Reflection is integral to the University's sustained community engagement and has contributed to the impact of the engagement for students, staff and the institution as a whole as well as for the communities with which the University is engaged.

Institute for Advancing Community Engagement

ACU National's Institute for Advancing Community Engagement (IACE) was created to promote its Beyond Today agenda and the three priority areas of Beyond Disadvantage, Beyond Borders and Beyond Differences. In 2007, IACE extended its University-wide programs such as Clemente Australia, capacity building in East Timor, and the Beyond Today Leadership Program, while also liaising with faculties, institutes and centres.

Beyond Disadvantage

The benefits of Clemente Australia for people who are marginalised and disadvantaged are evidenced in student outcomes, and the reports of agency and University staff and learning partners. The ABC 7.30 Report presented the story of Clemente Australia in ways which captured the minds and hearts of many Australians. Collaborative inter-agency meetings at regional and local levels in Sydney, Brisbane, Melbourne, Canberra, Campbelltown, Ballarat and the Hunter Valley provide further evidence of the value people and institutions see in this program. Disadvantaged people and community agencies seek the collaboration of ACU National in offering Clemente Australia as an important pathway for people to gain a sense of hope and re-engage with the community.

The University values the endorsement of this program through the collaborative support of the St Vincent de Paul Society, Mission Australia and Smith Family at national and local levels and in joint research ventures.

Among the 2007 Clemente Australia initiatives was a unique drama performance at the Brisbane Campus, Kin, featuring students who are homeless and marginalised sharing moving snapshots of their lives. Other Clemente Australia activities included art courses, performances of Shakespeare, theology lectures and more.

Beyond Borders

Hope for people in challenging situations is integral to the University's mission and community engagement and, in this spirit, throughout a period of national unrest, the institute maintained its services supporting the Instituto Católico para Formação de Professores (ICFP), also known as the Catholic teachers' college, in Baucau, East Timor. Original plans for reciprocal student engagement in 2007 across ICFP and ACU National have been modified from student visits to communication in Tetun and English through the internet in 2007 moving to student visits in 2008 to coincide with World Youth Day. Together with ICFP, IACE is documenting the history, processes and outcomes of the partnership in East Timor.

The University maintained its engagement with Karen refugees on the Thai Burmese border, through the Faculty of Arts and Sciences, and with the Notre Dame Institute of Education (NDIE) in Karachi, Pakistan, through the Faculty of Education. The Diocese of Jaffna, Sri Lanka, and the Mountain of the Moons University, Uganda, also sought support from the University.

Beyond Differences

The Beyond Today Leadership Program for 20 young Muslim leaders from Melbourne took participants into new understandings of Beyond Differences in religious traditions, particularly through the home stay component of the program.

Based at the Strathfield Campus, hosted by IACE and La Trobe University's Centre for Dialogue, the program was sponsored by the Islamic Council of Victoria and the Victorian Government.

Participants explored leadership issues with University students, graduates and staff from the University's Mission Engagement Team, Yalbalinga Indigenous Unit, the Asia-Pacific Centre for Interreligious Dialogue, and Flagship for Creative and Authentic Leadership as well as members of partner organisations including the Affinity Intercultural Foundation, Columban Mission Institute, Diocese of Parramatta, Edmund Rice Centre, Islamic Council of NSW, and Islamic Friendship Association of Australia.

Those involved gained new insights into different faith traditions and cultures which provided a rich basis for understanding the role of young leaders in a diverse and rapidly changing world.

In other programs hosted by IACE, Buddhist and Muslim visitors from southern Thailand met to discuss common concerns, while a visit by Bethlehem Mayor Dr Victor Batarseh provided an opportunity for people from many varied institutions to reflect upon the importance of sacred places and the implications for Australians and people in Bethlehem.



2007 Outstanding Community Engagement Awards

Staf

School of Arts and Sciences Head of School Dr Lindsay Farrell received the 2007 staff award in recognition of his genuine commitment to community engagement through a range of areas involving art over many years, including work with the Prison Fellowship Queensland, Indigenous art exhibitions, international aid development programs and refugees.

Student

Melbourne Campus first-year social science student Coni Forcey received the 2007 student award in recognition of her passionate concern with the environment, forming the Bayside Climate Change Action Group and engaging with government, business, local council, community groups and residents.

Community

The Clemente Australia program received the inaugural Vice-Chancellor's Award for Outstanding Community Engagement.

Faculty contributions

Community engagement is part of the student experience at ACU National, with opportunities for engagement woven into the academic and social fabric of the University.

Education students from the Brisbane Campus worked as voluntary English teaching assistants at the Catholic University of Daegu's English Village in South Korea.

The Faculty of Education engaged with schools through the Australian Schools Innovation in Science, Technology and Mathematics (ASISTM) Critical Friend Program, enhancing the teaching and learning of science, technology and mathematics in schools.

Sudanese students were given opportunities to extend their literacy skills by working with Brisbane Campus education students in homework clubs, literacy blocks and other literacy activities. The project is supported by Brisbane Catholic Education and the Brisbane Campus Mission Engagement team.

The Faculty of Education continued to work for improved outcomes for rural, remote and Indigenous communities through creating an online professional learning community for rural and remote teachers, *The way forward for teachers in rural and regional schools* project.



A further project, *Using Indigenous students' oral language as the foundation for literacy and numeracy learning*, supports Indigenous students' learning as they transition from home to school. Both projects involve partnerships with Catholic Education Office (Cairns), Independent Schools Queensland, and primary schools in North Queensland and remote areas of NSW.

The School of Religious Education hosted the highly successful 2007 Fifth National Symposium on Religious Education and Ministry.

ACU National, IBM, Sydney University's Science Foundation for Physics and the NSW Department of Education and Training began collaborating in a ground-breaking science education program for Sydney primary schools. The MyScience pilot project aimed to improve the delivery of science, engineering and technology education in schools and to ignite students' interest.

The Faculty of Health Sciences established linkages with 21 universities and institutions in countries which include China, Korea, USA, Vanuatu, Sweden, Japan, Hong Kong, United Kingdom, Finland and Philippines, creating opportunities for student and staff exchanges, study abroad and study tours.

The University helped fund a clinic in East Timor through providing the salary of a local registered nurse, and staff and students travelled to Vanuatu for two weeks to work with community health nurses. Students were billeted with local families in rural villages to provide them with experience of cultural immersion and to enable them to participate in

family and community activities such as play groups, health promotion and school and community health programs. The School of Nursing (NSW & ACT) raised funds for scholarships, equipment for the hospital and clinics; and text books for the School of Nursing in Vanuatu.

Academic staff took part in the KAIROS Prison Ministry, providing ministry support to prisoners in Sydney, while, in conjunction with the Consul-General of Solomon Islands, an academic staff member assisted in transport and support of patients from the Solomon Islands who received medical treatment at St Vincent's Hospital in Sydney.

In a joint project between the School of Nursing and Midwifery (NSW and ACT) and Broken Hill Department of Rural Health, students received scholarships from the University of Sydney Indigenous Unit to spend two weeks in Broken Hill to participate in health promotion activities as well as experience the way of life of Australian Indigenous communities.

Health sciences staff took part in the Aged Care Channel on-air video and talk back question and answer sessions on dementia, delirium and depression in residential facilities, broadcast to staff working in 800 nursing homes throughout Australia.

Other key events in brief

Social Justice Youth Forum

ACU National held its third annual forum for secondary school students at the Brisbane Campus to encourage and inspire young Australians to become involved in social justice and make a difference in their local communities. The keynote address was delivered by the Governor of Queensland, Her Excellency Ms Quentin Bryce.

Depression expert

ACU National hosted renowned US depression expert Dr Michael Yapko who delivered a range of lectures to professionals and the public during the year.

Global citizens

Australia's responsibilities were discussed at a social justice forum at the Strathfield Campus, hosted by the IACE and featuring ACU National Professor of Law Father Frank Brennan SJ AO and retired Secretary General of global aid agency Caritas Internationalis and Visiting Professor Duncan MacLaren from Glasgow. They discussed the Catholic Bishops of Australia's latest Social Justice Sunday Statement, Who is my neighbour? Australia's role as a global citizen.

The University's Melbourne Campus hosted the International Council of Universities of St Thomas Aquinas (ICUSTA) conference, involving more than 30 Catholic universities from around the world. It was the first time the conference has been held in Australia.

Thai delegation

IACE welcomed a delegation of Thai visitors, from the Province of Pattani, to the Strathfield Campus. In a country that is predominantly Buddhist, differences in history, culture and religion have all contributed to the recent violence and instability in Pattani, Yala and Narathiwat, the three southern most provinces of Thailand, where the majority of the population is Muslim.

The visitors engaged with students and staff from the University, members of the Columban Mission Institute team and representatives of the Affinity Intercultural Foundation.

Supporting IACE initiatives in East Timor

More than 70 people from diverse organisations and many parliamentarians attended an event at NSW Parliament House, raising \$5,000 for the Catholic teachers' college in Baucau, East Timor. All learnt more about teacher education initiatives in East Timor supported by the Marist Brothers, ACU National and others, and heard from the Founding Director of the College Brother Mark Paul FMS, the Consul-General of East Timor Abel Gutterres and the Deputy Speaker of the House The Hon Tony Stewart MP.

Honour for Chancellor

In 2007, ACU National Chancellor Brother Julian McDonald CFC AO was awarded an Honorary Doctorate by Divine Word University (DWU) in Papua New Guinea, in recognition of Br McDonald's long years of advocacy for the rights of children in Australia and his contribution to higher education. DWU President Father Jan Czuba said Br McDonald had also been instrumental in forming strong links between ACU National and DWU, helping the latter to develop its academic credentials, infrastructure and information services in its early years.

Visual arts

The visual arts assist in projecting the Mission of the University, both through works of arts in the University's collection displayed on its campuses and exhibitions in its public galleries. Overseen by the University Galleries Committee, exhibitions enhance community engagement.

Exhibitions included the 2007 Clancy Prize for Religious Art (Strathfield); artwork from past and present students of the Academy of Mary Immaculate to commemorate the 150th anniversary of the arrival of the Sisters of Mercy in Victoria (Melbourne); an exhibition of major Indigenous work from Torres Strait Island artist Dennis Nona entitled Sesserae. Mr Nona was awarded the Telstra Indigenous Art Prize in 2007 (Brisbane).

Art from Inside, curated by Prison Fellowship Australia, appeared at the Brisbane and Strathfield campuses; the Canon World Photo exhibition at Strathfield; and Child-life on the Station, a series of art pieces from children from remote stations of Central and Southwest Queensland.

Keeping communities informed

The University's communication and marketing activities form an essential component of our engagement with partners and stakeholders, prospective and current students, staff, media and the broader community. In 2007, University Relations proudly related ACU National's Mission and achievements to prospective students, current students and staff, graduates, friends and benefactors of the University, as well as to employers and the broader community.

Strategies were informed by regular consultations, focus groups and market research which included measuring responses to marketing campaigns. This information was made available to intranet users, along with access to media coverage, via a new media hub.

ACU National's major stakeholder communications in 2007 included the Annual Report and three strategically-focused editions of the University's flagship publication *acunique*.

The 2006 Annual Report took an innovative approach, exploring five key themes drawn from ACU National's Mission and strategic plan. The title 'origins', inspired both by the University's heritage and an evocative student artwork, provided a framework to tell the story of the achievements and successes of the year.


The themes of *acunique* in 2007 were philanthropy, which explored how ACU National's supporters are helping us to deliver on our Mission; quality learning outcomes and the nurturing of excellence in our staff, students and programs; and the impact and value of the University's community engagement initiatives.

University Relations kept staff, students and friends of the University informed through the fortnightly online newsletter *ACU National Update*, web news and an online calendar of events. Campus and course guides and other publications were also produced, including support for the communication activities for faculties, schools and directorates across the University.

University Relations provided media relations support for ACU National events, initiatives and achievements, and integrated key messages and activities through reinvigorated faculty marketing and communications committee meetings and smaller working groups.

Communications staff worked with academics and general staff, students, graduates and partners of the University to promote their research, teaching innovations and expertise to the media and public. Strong coverage occurred in national and international radio, opinion columns in daily and community newspapers and specialist magazines, with staff achievements, community engagement activities and the Mission of the University gaining particular prominence.



Reaching out to prospective students

Student recruitment team members visited more than 460 schools and 70 major career markets, and hosted open days and similar events. We were the only university with representatives at the Gold Coast Schoolies' Week, where great interest was created not only by the helpful information but by the branded merchandise. Such initiatives reached over 100,000 school students during the year.

Profiling graduates and students through online video testimonials, University Relations further developed its undergraduate and postgraduate recruitment campaign websites and change of preference website. Student recruitment advertising campaigns were extended into new areas such as outdoor media in Brisbane, Sydney, Canberra, Ballarat and Melbourne. The annual mid-year entry campaign was developed in response to University priorities.

University Relations developed information management systems and reports enabling the University to monitor, review and refine its marketing activities. The University's advertising campaigns were creatively expanded following careful monitoring of growing interest in courses through applications, demographic and geographic statistical data analysis.

The University's public relations exercises are aimed at strengthening our branding and enhancing recognition of ACU National's unique Mission, teaching, research and engagement.

It is through valued partnerships that ACU National is able to extend both its own influence and that of our partners. Together, we achieve more.

Collaboration occurred at a multitude of levels. Donors and other friends of the University helped us to initiate new projects, advocate on our behalf and strengthen and broaden our existing work in teaching, research and community engagement.

In 2007, it was the support of partners which led to the establishment of influential new Chairs in law, in health and in inter-religious dialogue. Partnerships also made tertiary study possible for scholarship winners across the country, enriched quality teaching, learning and research, and enhanced community engagement initiatives locally, nationally and internationally.

Graduates and honorary doctorates deepened the University's expertise and influence in the vital fields of education, health sciences and human services.

ACU National has numerous cooperative ventures with partner institutions within Australia and internationally. These partnerships enable collaboration in teaching and learning, research, community engagement, and industry and regional development.

Partnership in aged care

ACU National and Catholic Homes for the Elderly (CHE) announced a jointly funded Associate Professor of Aged Care in Victoria, to be based both at ACU National's Melbourne Campus and at various CHE facilities. Dr Fran McInerney will conduct evidence-based research into local aged care services to help inform industry policy and best practice.

Industry partnerships in exercise science

In 2007, the School of Exercise Science (NSW) formed a number of partnerships with industry organisations to enhance both field and industry experience for students and the business of the organisations. Some 12 organisations, ranging from Police Youth clubs to the Paralympics Committee, agreed to provide structured and supervised placements to 100 students. A forum for first and second year students was also held to advise students on opportunities for industry placements and an ACU National plaque was presented to representatives from the organisations in appreciation of their support.

Graduations and the graduate association

During 2007, 3,761 students graduated in ceremonies organised by Graduate Relations. There were 11 domestic ceremonies in Brisbane, Sydney, Canberra, Ballarat and Melbourne, and international ceremonies in Shanghai, Baucau and Hong Kong, presented in dual languages.

The University also celebrated the graduation of the one thousandth graduate in Hong Kong, Mr Lo Kai Cheong, along with the launch of the Hong Kong chapter of the Graduate Association.

In 2007, 31 doctoral awards were conferred, 20 in Philosophy, 7 in Education and 4 in Psychology.

Strong relations between ACU National and the Shanghai Institute of Health Sciences (SIHS), within Shanghai Jiao Tong University School of Medicine (SJTUSM), were celebrated at the 2007 graduation ceremony in Shanghai, China. SIHS is recognised by the Chinese Government as an 'Institute of

Excellence' in the field of nursing and has a reputation for its leadership in advancing nursing education in China. Since 2001, through a number of short-term professional development programs and the Master of Nursing program, ACU National has helped educate a large number of China's senior nursing staff.

The Sydney Spring ceremony was the final graduation ceremony involving the Dean of Students Professor Tim O'Hearn and Vice-Chancellor Professor Peter Sheehan AO, both of whom were to retire in 2008. Their contributions to the University over many years were warmly acknowledged.

Australian Catholic University Foundation

The Australian Catholic University Foundation was established in 1993 to nurture the University's diverse areas of interest and provide a focus for individual, corporate and community energy and funds.

The Foundation raises funds to support the University's strategic academic initiatives, teaching and research projects, national and international community and outreach projects, and scholarships and bursaries for its students and to support the University's capital development program and facilities.

The University's commitment to the development of these and other partnerships with the community has been strengthened by the establishment of a fundraising and development team within the University Relations Directorate.

Highlights

Over the course of 2007, the University continued to enjoy the wide support of many donors and a number of new partnerships were initiated. Major University projects were realised through significant external support.

The Allan Myers AO QC Chair of Law has been funded for a period of five years through the generous \$1 million donation from eminent Melbourne lawyer Mr Allan Myers QC. The position is based at the University's Melbourne Campus and will coordinate the University's Institute of Legal Studies across its six campuses.

Associate Professor Spencer Zifcak was appointed to the Chair and as Director of the University's Institute of Legal Studies, established as a national initiative of ACU National, to foster legal professional development education and to promote interdisciplinary studies in law with a focus on ethics, philosophy and theology.

Allan Myers and his wife Maria have been long-time supporters of the University and the establishment of this named Chair has allowed the University to honour Mr Myers in a significant way.

The Fethullah Gülen Chair in the Study of Islam and Muslim-Catholic Relations was established and is located in ACU National's Asia-Pacific Centre for Interreligious Dialogue (APCID) at the Melbourne Campus. Dr Ismail Albayrak was appointed as the inaugural Chair to commence in 2008.

"It is my hope that the Allan Myers Chair of Law will build upon ACU National's foundation of academic excellence by overseeing the provision of quality legal education with a strong focus on issues of ethical practice and social justice."

The Chair is being funded through a partnership with the Australian Intercultural Society, a non-profit Melbourne-based organisation aimed at promoting greater dialogue between Australia's various faith communities. It was named in honour of Fethullah Gülen, a Turkish-born scholar, educator, spiritual and social leader, and renowned advocate for interreligious dialogue and peace.

The Chair of Midwifery is a joint initiative by the Mater Health Services (Brisbane) and ACU National. The Chair of Midwifery will provide leadership in the critical examination of current trends and evidence-based practice in midwifery, and the related implications for research, education and practice. The Chair will be appointed during 2008.

Restoration of Central Hall

Central Hall, the 103-year-old ornate performance venue in Brunswick Street, Fitzroy, the 'jewel in the crown' of the Melbourne campus, was formally re-opened following significant heritage renovation. Funding for the \$3 million restoration of this historic building was provided by the lan Potter Foundation, the Catholic Archdiocese of Melbourne, ACU National and a grant from the Australian Government through the National Heritage Investment Initiative. While there is still additional work to be carried out to provide 21st-century facilities, Central Hall is now back to its former glory. The venue was officially re-opened by Lady Primrose Potter AC, Life Governor of the lan Potter Foundation, Archbishop Denis Hart and Victorian Senator Judith Troeth.

Community engagement

Through the generosity of donors including staff and students, the University continued to provide support for health and education in East Timor. Support also enabled a third cohort of teachers from Catholic Schools in the Mauritius Diocese of Port Louis to undertake Master of Educational Leadership studies through the University's School of Educational Leadership. This outreach program represents a significant collaboration between the University, the Diocese of Port Louis and its Australian supporters, generally members of Sydney's Mauritian community.

Enhanced policy framework

Reflecting the increased priority the University has given to securing and maintaining the support of donors and other friends in the community, there has been an extensive revision of internal policy and procedures to facilitate this important activity.

With commitment to social justice at the heart of our Mission, care for staff and students as individuals is a guiding priority in the development and implementation of the University's management policies and approach to good governance.

Leading by example, in 2007 the University continued to embrace flexibility for its workforce, introducing a ground-breaking Pathways to Retirement policy for staff and taking a lead position in gender equity in the Australian universities sector.

With commitment to best practice and breadth of talent, the University also actively sought to increase the number of Indigenous staff members employed. Details on these and other leadership initiatives follow.

Employee relations

Throughout 2007 employee relations focus necessarily remained on the implementation of the former Commonwealth Government's Workchoices legislation, and its ongoing Higher Education Workplace Relations Requirements (HEWRRs), specifically workplace policies and practices. Some 30 human resources and related policies and guidelines were assessed by the then Department of Education Science and Training, as part of the University's formal submission. The University was advised that its third application for an additional 7.5 per cent funding under the Commonwealth Grant Scheme was successful.

Further changes to the Federal Government's Workchoices legislation, which amended the *Workplace Relations Act, 1996* and its *Regulations*, required the University to review and update numerous policies and procedures. These included the introduction of the Government's 'fairness test' for Australian Workplace Agreements (AWAs),

and the requirement for employers to distribute the Government's associated 'fact sheet' to all employees.

ACU National's Staff Consultative Committee met five times in 2007, receiving regular reports on Equity and Diversity, Occupational Health, Safety and Wellbeing, General Staff Training and Development and Academic Staff Professional Development. The Committee considered a variety of human resources and workplace relations matters and a range of Human Resources and related policies, guidelines and procedures.

Recognition for innovation, diversity and opportunity

For an ageing workforce

The University continued to implement its innovative *Pathways to retirement* program which has been highly regarded within the broader national human resources sector. This was demonstrated when the University became a finalist for two prestigious national Human Resources awards:

- The Australian HR Awards, 2007 (in the category of: Best Mature Age Workforce Implementation)
- The Innovation Award from the Australian Human Resources Institute (AHRI) Awards for Excellence, 2007.

During 2007, the University continued to introduce progressive staff equity and diversity workplace reforms, consistent with its Mission.

In cooperation with the Business, Work and Ageing Centre for Research at Swinburne University of Technology, ACU National participated in an ARC-funded project, *Redesigning work for an ageing society*, which is linked into similar research being conducted in Europe. Staff members were invited to complete a *Workability* survey, with 51 per cent of ACU National staff choosing to participate.

For cultural awareness

The University's Indigenous Employment Officer developed and presented a program of cultural awareness training for staff and supervisors at each campus, a major component of the University's Indigenous employment strategy. Cultural awareness training lays the foundations of respect and understanding for individuals working with Indigenous Australians, and is an important step in the successful recruitment and retention of Indigenous employees.

For gender equity

A report released in 2007, Selected inter-institutional gender equity statistics, compared gender representation in Australian universities. In particular it focused on the representation of women in senior roles in Australian higher education institutions, both general and academic. The analysis showed that ACU National was consistently in the top three for overall female representation, a result also reflected at a senior level. The ratio of female representation in senior positions was approximately 1.1, which compares with a sector average of 0.66 for general staff. For academic staff, the result was 0.85, compared to a sector average of 0.58. Women in senior general staff positions at ACU National are represented at a higher level than their male counterparts in senior roles, and are close to reaching parity in the academic area.

The report also provided information regarding the overall representation of female academics since 2004, showing a steady increase at ACU National in all the categories reported. The results provide clear evidence that the University has taken a leading role in regard to gender equity in Higher Education.

Workforce planning

The University has been progressively developing and implementing a workforce planning framework that is in harmony with its Mission and in line with the University's strategic initiatives and priorities. Development began on a People and Culture Plan which includes strategic workforce planning as one of its key strategies.

In 2007, the University considered an initial workforce profile report which analysed statistical data relevant for workforce planning, and resolved that strategic workforce management was to be given a high priority at ACU National. Workforce planning is at the forefront of strategic University issues, supported by comprehensive data collection and a formal policy statement and procedures. The workforce planning procedures are to be implemented as a pilot in 2008.



The student experience

True to our Mission, ACU National's community of learning values equity, social justice and respect for the individual. Graduates and students attest to the value of the personal approach made possible by our small class sizes and diverse campuses.

Importantly, student services in 2007 supported both the learning and extra-curricular environment. For example, when the former Federal Government introduced Voluntary Student Unionism legislation, Vice-Chancellor Professor Peter Sheehan AO provided a \$100,000 grant to ensure that key student initiatives went ahead. These funds also helped provide equity bursaries and varied support for students in need.

From the rolling out of the First Year Experience program welcoming new students, to a commitment in 2007 to provide careers' advisors at all campuses, the University worked to maximise the well-being of students at every level.

ACU National Student Association (ACUNSA) presidents from each campus gathered at the Brisbane Campus to discuss national issues and events. They met key University staff and past student presidents, to find ways of offering students 'the best campus life

possible' in the face of Voluntary Student Unionism, and to plan parties, field trips, games nights, barbecues, street retreats, soup kitchens, movie nights and a Uni Ball. All students are encouraged to support ACUNSA by becoming a member or representative, and to find out about events on their campus by visiting my.acu.edu.au/student/community/student_associations and meeting their local representatives.

The University celebrated its unique national character with the inaugural ACU National Games held at the Canberra Campus. Students from every campus were invited to take part in teams for mixed netball, ultimate Frisbee, dodgeball and ultimate soccer, interspersed with a wide range of social activities.

Students from all campuses met at the Strathfield Campus to take part in ACU Alive, a four-day program showcasing cultural talents, culminating in a collaborative public performance for which entry fees were donated to East Timor's graduate teachers' program.

The program included the launch of ACU National's radio station, *Wired*, a joint staff-student initiative aimed specifically at strengthening the University's national identity.





Senior management profiles

Chancellor

Brother Julian McDonald CFC AO BA DipEd (Syd), CertRelFormation (St Louis), GradDipLangInEd (CSU)

Brother Julian was appointed Chancellor of ACU National in November 2000. He has been a member of the University Senate since 1992, and was previously Pro-Chancellor from 1995–2000. In October 2002, Brother Julian concluded a 12-year term as Province Leader of the Christian Brothers in NSW, ACT and Papua New Guinea. He is currently a member of the Leadership Team of the Christian Brothers, Oceania Province and he is a consultant to the National Committee for Professional Standards – a committee of the Australian Catholic Bishops Conference and Catholic Religious Australia. Brother Julian was made an Officer in the General Division of the Order of Australia in 2003. He joined the Christian Brothers in 1960 and went on to gain a Bachelor of Arts and Diploma of Education at the University of Sydney. He received a Certificate of Religious Formation from St Louis University and a Graduate Diploma in Language in Education from Charles Sturt University. In 1973 he became Director of Christian Brothers Formation at Strathfield, NSW, and held this position until 1981. Brother Julian spent two years (1988–1990) in Rome as Director of Christian Brothers' International Renewal Program. He has an Honorary Doctorate from Divine Word University, Madang, PNG.

Pro-Chancellor

Edward Exell AM BA (Hons) (Melb), BEc (ANU)

Mr Exell has been Pro-Chancellor of the University since November 2000. He has recently retired as the Business Manager of the Catholic Archdiocese of Melbourne. He is Chair of the Standing and Finance Committee of the University. Mr Exell was born in Melbourne and educated at Xavier College, Melbourne, Loyola College, Watsonia, as a Jesuit scholastic, and at the Australian National University. Before joining the Catholic Archdiocese he was Deputy Managing Director of the Australian Trade Commission. Mr Exell has served on the National Board of Employment Education and Training, the Mercy Health and Aged Board and, until recently, was a member of the School Council of Xavier College. He was made a Member in the General Division of the Order of Australia in 1988.

Vice-Chancellor

Professor Peter Sheehan AO BA (Hons), PhD (Syd), FAPS, FAPSA, FASSA, FACE

Professor Sheehan was appointed Vice-Chancellor of ACU National in February 1998. During his 10-year term as Vice-Chancellor, his responsibilities within the sector included membership of the Australian Vice-Chancellors' Committee (AVCC) and its Board (later to become Universities Australia); the Expert Advisory Group on the Research Quality Framework (RQF); and its modelling sub-group; Chair of the AVCC working party on the RQF; Board Member of the Australian Universities Quality Agency, and the Business and Higher Education Round Table and Commissioner of the National Catholic Education Commission.

Professor Sheehan obtained a Bachelor of Arts with Honours from the University of Sydney in 1961 and was awarded a Doctor of Philosophy in Psychology in 1965. After completing a postdoctoral fellowship at the University of Pennsylvania Hospital from 1965 to 1967, he was Assistant Professor Psychology at the City College of the City University of New York from 1967 to 1968, lecturer and senior lecturer at the University of New England, Armidale from 1968 to 1972, and Professor of Psychology at the University of Queensland from 1973 to 1997.

He was Chair of the Queen Elizabeth II Fellowships and Australian Research Grants Committee, and is past Chair of the Council's Social Sciences and Humanities Panel. He is also Past President of the Australian Psychological Society and was President of the International Congress of Psychology in 1988. From 1991 to 1993 he held office as President of the Academy of the Social Sciences in Australia, and was made Honorary Fellow of the Academy in 1996. He was a member of the Commonwealth Cinematograph Films Board from 1982–1987 and its Chair from 1986–1987. Professor Sheehan was made an Officer in the General Division of the Order of Australia in 1995, and received the Centenary Medal in 2003.

Pro-Vice-Chancellor (Academic Affairs)

Professor Gabrielle McMullen BSc (Hons), PhD (Monash), FRACI

Professor McMullen has held her current appointment as Pro-Vice-Chancellor (Academic Affairs) since 2000. She is responsible for the ACU National Faculties, Library, online education and academic staff professional learning as well as the Victorian operations of the University. She was previously Rector of the Ballarat Campus for five years.

Prior to joining ACU National, Professor McMullen worked at the Chemical Institute of the University of Freiburg, Germany as a postdoctoral fellow and then in the Department of Biochemistry and Molecular Biology at Monash University. She was also Dean of Mannix College at Monash University. She has held fellowships from the Alexander von Humboldt-Stiftung and the Deutsche Forschungsgemeinschaft, and is a Fellow of the Royal Australian Chemical Institute. Professor McMullen's current research interests include Catholic higher education.

Pro-Vice-Chancellor (Research and International)

Professer Peter Wilson BA (Hons), PhD (UNSW)

Professor Peter Wilson took up the position of Pro-Vice-Chancellor (Research and International) in May 2006. He was previously Professor and Head of Psychology at Southern Cross University where he established a new School of Psychology.

He also occupied the position of Associate Dean (Coffs Harbour Campus) in 2002. Professor Wilson undertook his studies at the University of New South Wales where he was awarded a Bachelor of Arts (Honours) degree in 1975 and a PhD in Psychology in 1980.

Professor Wilson's research has been in the area of clinical and health psychology. In particular, he is well known internationally for his research on psychological aspects and management of tinnitus (ringing in

the ears). He has also published work in the area of cognitive-behaviour therapy for depression. He received a Distinguished Career Award in 1998 from the Australian Association for Cognitive and Behaviour Therapy. He has held NHMRC grants for research on psychological aspects of tinnitus and diabetes, and has published extensively on topics in the area of clinical and health psychology.

Professor Wilson is a member of the Pro-Vice-Chancellor (Research) and the Pro-Vice-Chancellor (International) sub-committees of the Australian Vice-Chancellors' Committee. He also chairs the NSW PVC/DVC (International) committee. He is a former Chair of the Heads of Departments and Schools of Psychology Association (2002–2003), and the National President of Australian Behaviour Modification Association (1986–1987). For the Australian Psychological Society, Professor Wilson has served as a member of the Professional Development Accreditation Advisory Group from 1996–2006.

Pro-Vice-Chancellor (Quality and Engagement)

Professor John O'Gorman BA (Hons), PhD (Qld), FAPS

Professor O'Gorman commenced as Pro-Vice-Chancellor (Quality and Engagement) in February 2004 and is based on the Brisbane Campus.

Before joining ACU National, Professor O'Gorman was Foundation Professor of Psychology at Griffith University, where he was Dean of Health Sciences for almost 10 years. Prior to that he was at the University of New England, Armidale where he was for three years Dean of the Faculty of Arts.

Professor O'Gorman is a Fellow of the Australian Psychological Society, a former Chair of the Psychologists Board of Queensland (1992 to 1998) and a former Editor of the Australian Journal of Psychology (1991–1994).


